1 Overview

In this report, we present systematic analyses of the Match-up DataBase (MDB) files generated by the Pi-MEP platform within the following Pi-MEP region and for the below pair of Satellite/in situ SSS data:

- Pi-MEP region: Southern Ocean (download the corresponding mask in NetCDF here)
- SSS satellite product (SSS_{SAT}): ISAS
- In situ dataset (SSS_{Insitu}): TSG (GOSUD-Research-vessel) (download the corresponding in situ report here)

In the following, $\Delta SSS = SSS_{SAT}$ - SSS_{Insitu} denotes the difference between the satellite and *in* situ SSS at the colocalized points that form the MDB.

2 The MDB file datasets

2.1 Satellite SSS product

2.1.1 ISAS

The In Situ Analysis System (ISAS), as described in Gaillard et al. (2016) is a data based reanalysis of temperature and salinity fields over the global ocean $70^{\circ}N-70^{\circ}S$ on a $1/2^{\circ}$ grid. It was initially designed to synthesize the temperature and salinity profiles collected by the Argo program. It has been later extended to accommodate all type of vertical profile as well as time series. ISAS gridded fields are entirely based on *in situ* measurements. The methodology and configuration have been conceived to preserve as much as possible the data information content and resolution. ISAS is developed and run in a research laboratory (LOPS) in close collaboration with Coriolis, one of Argo Global Data Assembly Center and unique data provider for the Mercator operational oceanography system.

In Pi-MEP, the products used are the ISAS20_ARGO for the period 2010 to 2020 and the INSITU_GLO_PHY_TS_OA_NRT_013_002 for the Near-Real Time (2021-2024) derived at the Coriolis data center and provided by the Copernicus Marine Environment Monitoring Service (CMEMS). The major contribution to the data set is from Argo array of profiling floats, reaching an approximate resolution of one profile every 10-days and every 3-degrees over the satellite SSS period. The ISAS optimal interpolation involves a structure function modeled as the sum of two Gaussian functions, each associated with specific time and space scales, resulting in a smoothing over typically 3 degrees. The smallest scale which can be retrieved with ISAS analysis is not smaller than 300–500 km (Kolodziejczyk et al. (2015)). For validation purpose, the ISAS monthly SSS fields at 5 m depth are collocated and compared with the satellite SSS products and included in the Pi-MEP Match-up files. In addition, the "percentage of variance" fields (PCTVAR) contained in the ISAS analyses provide information on the local variability of *in situ* SSS measurements within $1/2^{\circ}x1/2^{\circ}$ boxes.

The ISAS20_ARGO release is interpolated on 187 standard depth levels between 0-5500 m depth and 0.5°x0.5° global horizontal grid. ISAS20 use the version 8 of ISAS and updated statistics to produce the monthly analysis (Monthly Climatology and annual STD computed from WOA18A5B7). ISAS20 gridded fields analyze the Argo and Deep-Argo temperature and salinity data alone between 2002-2020.

Temperature and salinity fields from Near real Time analysis (2021-present) are used to extend the ISAS20 realanalysis toward the most recent periods.

"ISAS temperature and salinity monthly gridded field products are made freely available by SNO Argo France at LOPS Laboratory (supported by UBO/CNRS/Ifremer/IRD) and IUEM Observatory (OSU IUEM/CNRS/INSU)"

2.2 In situ SSS dataset

The TSG (GOSUD-Research-vessel) dataset corresponds to French research vessels SSS data that have been collected since the early 2000 as a contribution to the Global Ocean Surface Underway Data (GOSUD) program. The set of homogeneous instruments is permanently monitored and regularly calibrated. Water samples are taken on a daily basis by the crew and later analysed in the laboratory. The careful calibration and instrument maintenance, complemented with a rigorous adjustment on water samples, lead to reach an accuracy of a few 10^{-2} PSS in salinity. This delayed mode dataset (Kolodziejczyk et al. (2023)) is updated annually and freely available here. Adjusted values when available and only collected TSG data that exhibit quality flags 1 or 2 were used.

2.3 Auxiliary geophysical datasets

Additional EO datasets are used to characterize the geophysical conditions at the in situ/satellite SSS pair measurement locations and time, and 10 days prior to the measurements, to get an estimate of the geophysical concomitant condition and history. As discussed in Boutin et al. (2016), the presence of vertical gradients in, and horizontal variability of, sea surface salinity indeed complicates comparison of satellite and in situ measurements. The additional EO data are used here to get a first estimates of conditions for which L-band satellite SSS measured in the first centimeters of the upper ocean within a 50-150 km diameter footprint might differ from pointwise in situ measurements performed in general between 10 and 5 m depth below the surface. The spatio-temporal variability of SSS within a satellite footprint (50–150 km) is a major issue for satellite SSS validation in the vicinity of river plumes, frontal zones, and significant precipitation areas, among others. Rainfall can in some cases produce vertical salinity gradients exceeding 1 pss m^{-1} ; consequently, it is recommended that satellite and *in situ* SSS measurements less than 3-6 h after rain events should be considered with care when used in satellite calibration/validation analyses. To identify such situation, the Pi-MEP platform is first using CMORPH products to characterize the local value and history of rain rate and ASCAT gridded data are used to characterize the local surface wind speed and history. For validation purpose, the ISAS monthly SSS in situ analysed fields at 5 m depth are collocated and compared with the satellite SSS products. The use of ISAS is motivated by the fact that it is used in the SMOS L2 official validation protocol in which systematic comparisons of SMOS L2 retrieved SSS with ISAS are done. In complement to ISAS, monthly std climatological fields from the World



Ocean Atlas (WOA13) at the match-up pairs location and date are also used to have an a priori information of the local SSS variability.

2.3.1 CMORPH

Precipitation are estimated using the CMORPH 3-hourly products at 1/4° resolution (Joyce et al. (2004)). CMORPH (CPC MORPHing technique) produces global precipitation analyses at very high spatial and temporal resolution. This technique uses precipitation estimates that have been derived from low orbiter satellite microwave observations exclusively, and whose features are transported via spatial propagation information that is obtained entirely from geostationary satellite IR data. At present NOAA incorporate precipitation estimates derived from the passive microwaves aboard the DMSP 13, 14 and 15 (SSM/I), the NOAA-15, 16, 17 and 18 (AMSU-B), and AMSR-E and TMI aboard NASA's Aqua, TRMM and GPM spacecraft, respectively. These estimates are generated by algorithms of Ferraro (1997) for SSM/I, Ferraro et al. (2000) for AMSU-B and Kummerow et al. (2001) for TMI. Note that this technique is not a precipitation estimation algorithm but a means by which estimates from existing microwave rainfall algorithms can be combined. Therefore, this method is extremely flexible such that any precipitation estimates from any microwave satellite source can be incorporated.

With regard to spatial resolution, although the precipitation estimates are available on a grid with a spacing of 8 km (at the equator), the resolution of the individual satellite-derived estimates is coarser than that - more on the order of $12 \ge 15$ km or so. The finer "resolution" is obtained via interpolation.

In effect, IR data are used as a means to transport the microwave-derived precipitation features during periods when microwave data are not available at a location. Propagation vector matrices are produced by computing spatial lag correlations on successive images of geostationary satellite IR which are then used to propagate the microwave derived precipitation estimates. This process governs the movement of the precipitation features only. At a given location, the shape and intensity of the precipitation features in the intervening half hour periods between microwave derived features that have been propagated forward in time from the previous microwave observation and those that have been propagated backward in time from the following microwave scan. NOAA refer to this latter step as "morphing" of the features.

For the present Pi-MEP products, we only considered the 3-hourly products at 1/4 degree resolution. The entire CMORPH record (December 2002-present) for 3-hourly, 1/4 degree lat/lon resolution can be found at: ftp://ftp.cpc.ncep.noaa.gov/precip/CMORPH_V1. O/CRT/. CMORPH estimates cover a global belt (-180°W to 180°E) extending from 60°S to 60°N latitude and are available for the complete period of the Pi-MEP core datasets (Jan 2010-now).

2.3.2 ASCAT

Advanced SCATterometer (ASCAT) daily data produced and made available at Ifremer/CERSAT on a 0.25°x0.25° resolution grid (Bentamy and Fillon (2012)) since March 2007 are used to characterize the mean daily wind at the match-up pair location as well as the wind history during the 10-days period preceding the in situ measurement date. These wind fields are calculated based on a geostatistical method with external drift. Remotely sensed data from ASCAT are considered as observations while those from numerical model analysis (ECMWF) are associated with the external drift. The spatial and temporal structure functions for wind speed, zonal and meridional wind components are estimated from ASCAT retrievals. Furthermore, the new procedure includes a temporal interpolation of the retrievals based on the complex empirical orthogonal



function (CEOF) approach, in order to enhance the sampling length of the scatterometer observations. The resulting daily wind fields involves the main known surface wind patterns as well as some variation modes associated with temporal and spatial moving features. The accuracy of the gridded winds was investigated through comparisons with moored buoy data in Bentamy et al. (2012) and resulted in rms differences for wind speed and direction are about 1.50 m.s⁻¹ and 20° .

2.3.3 ISAS

The In Situ Analysis System (ISAS), as described in Gaillard et al. (2016) is a data based re-analysis of temperature and salinity fields over the global ocean $70^{\circ}N-70^{\circ}S$ on a $1/2^{\circ}$ grid. It was initially designed to synthesize the temperature and salinity profiles collected by the Argo program. It has been later extended to accommodate all type of vertical profile as well as time series. ISAS gridded fields are entirely based on *in situ* measurements. The methodology and configuration have been conceived to preserve as much as possible the data information content and resolution. ISAS is developed and run in a research laboratory (LOPS) in close collaboration with Coriolis, one of Argo Global Data Assembly Center and unique data provider for the Mercator operational oceanography system. In Pi-MEP, the products used are the INSITU_GLO_PHY_TS_OA_MY_013_052 for the period 2010 to 2021 and the IN-SITU_GLO_PHY_TS_OA_NRT_013_002 for the Near-Real Time (2022-2023) derived at the Coriolis data center and provided by the Copernicus Marine Environment Monitoring Service (CMEMS). The major contribution to the data set is from Argo array of profiling floats, reaching an approximate resolution of one profile every 10-days and every 3-degrees over the satellite SSS period (http://www.umr-lops.fr/SNO-Argo/Products/ISAS-T-S-fields/). The ISAS optimal interpolation involves a structure function modeled as the sum of two Gaussian functions, each associated with specific time and space scales, resulting in a smoothing over typically 3 degrees. The smallest scale which can be retrieved with ISAS analysis is not smaller than 300–500 km (Kolodziejczyk et al. (2015)). For validation purpose, the ISAS monthly SSS fields at 5 m depth are collocated and compared with the satellite SSS products and included in the Pi-MEP Match-up files. In addition, the "percentage of variance" fields (PCTVAR) contained in the ISAS analyses provide information on the local variability of *in situ* SSS measurements within $1/2^{\circ} x 1/2^{\circ}$ boxes.

2.3.4 World Ocean Atlas Climatology

The World Ocean Atlas (WOA) is a set of objectively analyzed (1° grid) climatological fields of *in situ* temperature, salinity and other variables provided at standard depth levels for annual, seasonal, and monthly compositing periods for the World Ocean. It also includes associated statistical fields of observed oceanographic profile data interpolated to standard depth levels on 5°, 1°, and 0.25° grids. We use these fields in complement to ISAS to characterize the climatological fields (montly mean and std) at the match-up pairs location and date.

2.4 Overview of the Match-ups generation method

The match-up production is basically a three steps process:

- 1. preparation of the input in situ and satellite data, and,
- 2. co-localization of satellite products with in situ SSS measurements.
- 3. co-localization of the in situ/satellite pair with auxiliary information.



In the following, we successively detail the approaches taken for these different steps.

2.4.1 In situ/Satellite data filtering

The first step consists in filtering TSG (GOSUD-Research-vessel) in situ data using the quality flags as described in 2.2 so that only valid salinity data remain in the final match-up files.

For high-spatial resolution in situ SSS measurements such as the Thermo-SalinoGraph (TSG) SSS data, as well as SSS data from surface drifters, an additional spatial filtering step is performed on the *in situ* data that will be eventually compared to the satellite SSS products. If R_{sat} is the spatial resolution of the satellite SSS product (L2 to L3-L4), the *in situ* data are spatially low pass filtered using a running median filter with a window width= R_{sat} to try to minimize the spatial representation uncertainty when comparing to the lower spatial resolution of the satellite SSS product. Both original and filtered *in situ* data are finally stored in the MDB files.

Only for satellite L2 SSS data, a third sub-step consists in filtering spurious data using the flags and associated recommendations as provided by the official data centers and described in 2.1.

2.4.2 In situ/Satellite Co-localization

In this step, each SSS satellite product is co-localized with the filtered *in situ* measurements. The method used for co-location is different if the satellite SSS is a swath product (so-called Level 2-types) or a time-space composite product (so-called Level 3/level 4-types).

• For L2 SSS swath data :

If R_{sat} is the spatial resolution of the satellite swath SSS product, for each *in situ* data sample collected in the Pi-MEP database, the platform searches for all satellite SSS data found at grid nodes located within a radius of $R_{sat}/2$ from the *in situ* data location and acquired with a time-lag from the *in situ* measurement date that is less or equal than ± 12 hours. If several satellite SSS samples are found to meet these criteria, the final satellite SSS match-up point is selected to be the closest in time from the *in situ* data measurement date. The final spatial and temporal lags between the *in situ* and satellite data are stored in the MDB files.

• For L3 and L4 composite SSS products :

If R_{sat} is the spatial resolution of the composite satellite SSS product and D the period over which the composite product was built (e.g., periods of 1, 7, 8, 9, 10, 18 days, 1 month, etc..) with central time t_o , then for each *in situ* data sample in the Pi-MEP database within the time interval $[t_o - D/2, t_o + D/2]$, the platform searches for all satellite SSS data of the composite product found at grid nodes located within a radius of $R_{sat}/2$ from the *in situ* data location. If several satellite SSS product samples are found to meet these criteria, the final satellite SSS match-up point is chosen to be the composite SSS with central time t_o which is the closest in time to the *in situ* data measurement date. The final spatial and temporal lags between the *in situ* and satellite data are stored in the MDB file.

Recently, in the context of the partnership with NASA, the Pi-MEP provides a new colocalization criterion that is applied only to L2 products, called "L2-Averaged". It consists in averaging all SSS L2 swath pixels falling in a spatio-temporal window defined by $R_{sat}=50$ km and $D = \pm 3.5$ days around the in situ location. The spatial and temporal lags stored in the MDB files correspond to the average of all lags for each in situ data.



2.4.3 MDB pair Co-localization with auxiliary data and complementary information

MDB data consist of satellite and *in situ* SSS pairs but also of auxiliary geophysical parameters such as local and history of wind speed and rain rates, as well as various information (climatology, distance to coast, mixed layer depth, barrier layer thickness, etc) that can be derived from *in situ* data and which are included in the final match-up files. The collocation of auxiliary parameters and additional information is done for each *in situ* SSS measurement contained in the match-up files as follows :

If t_{insitu} is the time/date at which the *in situ* measurement is performed, we collect:

- The ASCAT wind speed product of the same day than t_{insitu} found at the ASCAT $1/4^{\circ}$ grid node with closest distance from the *in situ* data location. We then store the time series of the ASCAT wind speed at the same node for the 10 days prior to the *in situ* measurement day.
- If the *in situ* data is located within the 60°N-60°S band, we select the CMORPH 3-hourly product that is closest in time from t_{insitu} and found at the CMORPH 1/4° grid node with closest distance from the *in situ* data location. We then store the time series of the CMORPH rain rate at the same node for the 10 days prior to the *in situ* measurement time.

For the given month/year of the *in situ* data, we select the ISAS and WOA fields for the same month (and same year for ISAS fields) and take the SSS analysis (monthly mean, std) found at the closest grid node from the *in situ* measurement.

The distance from the *in situ* SSS data location to the nearest coast is evaluated and provided in km. We use a distance-to-coast map at $1/4^{\circ}$ resolution where small islands have been removed.

When vertical profiles of salinity (S) and temperature (T) are made available from the *in situ* measurements used to build the match-up (Argo or marine mammals), the following variables are also included into each satellite/*in situ* match-up file:

- 1. The vertical distribution of pressure at which the profiles were measured,
- 2. The vertical S(z) and T(z) profiles,
- 3. The vertical potential density anomaly profile $\sigma_0(z)$,
- 4. The Mixed Layer Depth (MLD). The MLD is defined here as the depth where the potential density has increased from the reference depth (10 meter) by a threshold equivalent to 0.2° C decrease in temperature at constant salinity: $\sigma_0 = \sigma_{010m} + \Delta \sigma_0$ with $\Delta \sigma_0 = \sigma_0(\theta_{10m} 0.2, S_{10m}) \sigma_0(\theta_{10m}, S_{10m})$ where θ_{10m} and S_{10m} are the temperature and salinity at the reference depth (i.e. 10 m) (de Boyer Montégut et al. (2004), de Boyer Montégut et al. (2007)).
- 5. The Top of the Thermocline Depth (TTD) is defined as the depth at which temperature decreases from its 10 m value by 0.2°C.
- 6. The Barrier Layer thickness (BLT) is defined as the difference between the MLD and the TTD. If BLT<0, it corresponds to a vertically density compensated layer whose thickness is then the absolute value of (TTD-MLD).
- 7. The vertical profile of the buoyancy frequency $N^2(z)$

The resulting match-ups files are serialized as NetCDF-4 files whose structure depends on the origin of the *in situ* data and is described in section 2.4.4.

2.4.4 Content of the Match-Up NetCDF files

The content of the Match-Up NetCDF files for TSG (GOSUD-Research-vessel) is described here.

2.5 MDB characteristics for each specific *in situ*/satellite pair

2.5.1 Number of paired SSS data as a function of time and distance to coast




Figure 2: Number of match-ups between TSG (GOSUD-Research-vessel) and ISAS SSS as a function of time (a) and as function of the distance to coast (b) over the Southern Ocean Pi-MEP region and for the full satellite product period.

Figure 2 shows the time (a) and distance to coast (b) distributions of the match-ups between TSG (GOSUD-Research-vessel) and ISAS for the Southern Ocean Pi-MEP region and for the full satellite product period.

2.5.2 Histograms of the SSS match-ups




Figure 3: Histograms of SSS from TSG (GOSUD-Research-vessel) (a) and ISAS (b) considering all match-up pairs per bins of 0.1 over the Southern Ocean Pi-MEP region and for the full satellite product period.

Figure 3 shows the SSS distribution of TSG (GOSUD-Research-vessel) (a) and ISAS (b) considering all match-up pairs per bins of 0.1 over the Southern Ocean Pi-MEP region and for the full satellite product period.

2.5.3 Distribution of in situ SSS depth measurements




Figure 4: Histograms of the depth of the upper level SSS measurements from TSG (GOSUD-Research-vessel) in the Match-up DataBase for the Southern Ocean Pi-MEP region (a) and temporal mean spatial distribution of pressure of the *in situ* SSS data over $1^{\circ} \times 1^{\circ}$ boxes and for the full satellite product period (b).

Figure 4 shows the depth distribution of the upper level SSS measurements from TSG (GOSUD-Research-vessel) in the Match-up DataBase for the Southern Ocean Pi-MEP region (a) and temporal mean spatial distribution of pressure of the *in situ* SSS data over $1^{\circ} \times 1^{\circ}$ boxes and for the full satellite product period (b).

2.5.4 Spatial Distribution of Match-ups




Figure 5: Number of SSS match-ups between TSG (GOSUD-Research-vessel) SSS and the ISAS SSS product for the Southern Ocean Pi-MEP region over $1^{\circ} \times 1^{\circ}$ boxes and for the full satellite product period.

The number of SSS match-ups between TSG (GOSUD-Research-vessel) SSS and the ISAS SSS product for the Southern Ocean Pi-MEP region over $1^{\circ} \times 1^{\circ}$ boxes and for the full satellite product period is shown in Figure 5.





Figure 6: Histograms of the spatial (a) and temporal (b) lags between the location/time of the TSG (GOSUD-Research-vessel) measurement and the date of the corresponding ISAS SSS pixel.


3 MDB file Analyses

3.1 Spatial Maps of the Temporal mean and Std of *in situ* and satellite SSS and of their difference (Δ SSS)


In Figure 7, we show maps of temporal mean (left) and standard deviation (right) of the ISAS (top) and of the TSG (GOSUD-Research-vessel) in situ dataset at the collected Pi-MEP matchup pairs. The temporal mean and std are gridded over the full satellite product period and over spatial boxes of size $1^{\circ} \times 1^{\circ}$.

At the bottom of Figure 7, the temporal mean (left) and standard deviation (right) of the differences between the satellite SSS product and *in situ* data found at match-up pairs, namely Δ SSS(Satellite -TSG (GOSUD-Research-vessel)), is also gridded over the full satellite product period and over spatial boxes of size $1^{\circ} \times 1^{\circ}$.







3.2 Time series of the monthly median and Std of *in situ* and satellite SSS and of their difference (Δ SSS)




Figure 8: Time series of the monthly median SSS (top), median of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) and Std of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) over the Southern Ocean Pi-MEP region considering all match-ups collected by the Pi-MEP.

In the top panel of Figure 8, we show the time series of the monthly median SSS estimated over the full Southern Ocean Pi-MEP region for both ISAS satellite SSS product (in black) and the TSG (GOSUD-Research-vessel) *in situ* dataset (in blue) at the collected Pi-MEP match-up pairs.

In the middle panel of Figure 8, we show the time series of the monthly median of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) for the collected Pi-MEP match-up pairs and estimated over the full Southern Ocean Pi-MEP region.

In the bottom panel of Figure 8, we show the time series of the monthly standard deviation of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) for the collected Pi-MEP match-up pairs and estimated over the full Southern Ocean Pi-MEP region.

3.3 Zonal mean and Std of *in situ* and satellite SSS and of the difference (Δ SSS)

In Figure 9 left panel, we show the zonal mean SSS considering all Pi-MEP match-up pairs for both ISAS satellite SSS product (in black) and the TSG (GOSUD-Research-vessel) *in situ* dataset (in blue). The full satellite SSS product period is used to derive the mean.

In the right panel of Figure 9, we show the zonal mean of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) for all the collected Pi-MEP match-up pairs estimated over the full satellite product period.



3.4 Scatterplots of satellite vs in situ SSS by latitudinal bands




Figure 10: Contour maps of the concentration of ISAS SSS (y-axis) versus TSG (GOSUD-Research-vessel) SSS (x-axis) at match-up pairs for different latitude bands. For each plot, the red line shows x=y. The black thin and dashed lines indicate a linear fit through the data cloud and the $\pm 95\%$ confidence levels, respectively. The number match-up pairs n, the slope and R² coefficient of the linear fit, the root mean square (RMS) and the mean bias between satellite and *in situ* data are indicated for each latitude band in each plots.

In Figure 10, contour maps of the concentration of ISAS SSS (y-axis) versus TSG (GOSUD-Research-vessel) SSS (x-axis) at match-up pairs for different latitude bands: (a) 80° S- 80° N, (b) 20° S- 20° N, (c) 40° S- 20° S and 20° N- 40° N and (d) 60° S- 40° S and 40° N- 60° N. For each plot, the red line shows x=y. The black thin and dashed lines indicate a linear fit through the data cloud and the $\pm 95\%$ confidence levels, respectively. The number match-up pairs *n*, the slope and R² coefficient of the linear fit, the root mean square (RMS) and the mean bias between satellite and *in situ* data are indicated for each latitude band in each plots.

3.5 Time series of the monthly median and Std of Δ SSS sorted by latitudinal bands




Figure 11: Monthly median (red curves) of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) and ± 1 Std (black vertical thick bars) as function of time for all the collected Pi-MEP match-up pairs estimated over the Southern Ocean Pi-MEP region and for the full satellite product period are shown for different latitude bands: (a) 80°S-80°N, (b) 20°S-20°N, (c) 40°S-20°S and 20°N-40°N and (d) 60°S-40°S and 40°N-60°N.

In Figure 11, time series of the monthly median (red curves) of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) and ± 1 Std (black vertical thick bars) as function of time for all the collected Pi-MEP match-up pairs estimated over the Southern Ocean Pi-MEP region and for the full satellite product period are shown for different latitude bands: (a) 80°S-80°N, (b) 20°S-20°N, (c) 40°S-20°S and 20°N-40°N and (d) 60°S-40°S and 40°N-60°N.

3.6 \triangle SSS sorted as function of geophysical parameters




Figure 12: Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) sorted as function of TSG (GOSUD-Research-vessel) SSS values (a), ISAS SSS (b), ASCAT Wind speed (c), CCMP Wind speed (d), CMORPH rain rate (e) and IMERG rain rate (f). In all plots the median and Std of Δ SSS for each bin is indicated by the red curves and black vertical thick bars (±1 Std).




Figure 13: Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) sorted as function of TSG (GOSUD-Research-vessel) SST values (a), CMC SST (b), ERA5 SST (c), AVHRR SST (d), distance to coast (e) and distance to ice edge (f). In all plots the median and Std of Δ SSS for each bin is indicated by the red curves and black vertical thick bars (±1 Std). Links to similar figures sorted as function of Sea ice fraction and *in situ* measurement depth.

In Figures 12 and 13, we classify the match-up differences Δ SSS (Satellite - *in situ*) between ISAS and TSG (GOSUD-Research-vessel) SSS as function of the geophysical conditions at match-up points. The median and std of Δ SSS (Satellite - TSG (GOSUD-Research-vessel)) is thus evaluated as function of the

- in situ SSS values per bins of width 0.2,
- in situ SST values per bins of width 1°C,
- $\bullet\,$ CCMP 6h/ASCAT daily wind values per bins of width 1 m/s,

- IMERG 30 min/CMORPH 3-hourly rain rates per bins of width 1 mm/h,
- distance to the coast per bins of width 50 km,
- distance to the ice edge per bins of width 50 km,
- *in situ* measurement depth (if relevant),
- sea ice fraction per bins of width 10%,
- $\bullet~{\rm CMC}/{\rm ERA5}/{\rm AVHRR}~{\rm SST}$ values per bins of width $1^{\circ}{\rm C},$
- ISAS SSS values per bins of width 0.2.

3.7 Δ SSS maps and statistics for different geophysical conditions





Figure 14: Temporal mean gridded over spatial boxes of size $1^{\circ} \times 1^{\circ}$ of Δ SSS (ISAS - TSG (GOSUD-Research-vessel)) for 5 different subdatasets corresponding to:RR=0 mm/h, $3 < U_{10} < 12$ m/s, SST>5°C, distance to coast > 800 km (a), RR=0 mm/h, $3 < U_{10} < 12$ m/s (b), RR>1mm/h and $U_{10} < 4$ m/s (c), WOA2013 SSS Std<0.2 (d), WOA2013 SSS Std>0.2 (e).

In Figures 14 and 15, we focus on sub-datasets of the match-up differences Δ SSS (Satellite in situ) between ISAS and TSG (GOSUD-Research-vessel) for the following specific geophysical conditions:

• C1: if the local value at *in situ* location of estimated rain rate is zero, mean daily wind is in the range [3, 12] m/s, the SST is > 5°C and distance to coast is > 800 km.

- C2: if the local value at *in situ* location of estimated rain rate is zero, mean daily wind is in the range [3, 12] m/s.
- C3: if the local value at *in situ* location of estimated rain rate is high (ie. > 1 mm/h) and mean daily wind is low (ie. < 4 m/s).
- C5: if the *in situ* data is located where the climatological SSS standard deviation is low (ie. above < 0.2).
- C6: if the *in situ* data is located where the climatological SSS standard deviation is high (ie. above > 0.2).

For each of these conditions, the temporal mean (gridded over spatial boxes of size $1^{\circ} \times 1^{\circ}$) and the histogram of the difference Δ SSS (Satellite - *in situ*) are presented.

4 Summary

► Table 1 shows the mean, median, standard deviation (Std), root mean square (RMS), interquartile range (IQR), correlation coefficient (r^2) and robust standard deviation (Std^{*}) of the match-up differences Δ SSS (Satellite - *in situ*) between ISAS and TSG (GOSUD-Research-vessel) derived over the Southern Ocean Pi-MEP region and for the full satellite product period and for the following conditions:

- all: All the match-up pairs satellite/in situ SSS values are used to derive the statistics
- C1: only pairs where RR=0 mm/h, $3 < U_{10} < 12$ m/s, SST>5°C, distance to coast > 800 km
- C2: only pairs where RR=0 mm/h, $3 < U_{10} < 12$ m/s
- C3: only pairs where RR>1mm/h and $U_{10} < 4m/s$
- C5: only pairs where WOA2013 SSS Std<0.2
- C6: only pairs at WOA2013 SSS Std>0.2
- C7a: only pairs with a distance to coast < 150 km.
- C7b: only pairs with a distance to coast in the range [150, 800] km.
- C7c: only pairs with a distance to coast > 800 km.
- C8a: only pairs where SST is $< 5^{\circ}$ C.
- C8b: only pairs where SST is in the range [5, 15]°C.

- C8c: only pairs where SST is $> 15^{\circ}$ C.
- C9a: only pairs where SSS is < 33.
- C9b: only pairs where SSS is in the range [33, 37].
- C9c: only pairs where SSS is > 37.

5 More Comparison/Validation Materials

5.1 Comparisons with other satellite products

Caution has to be made in the interpretation of the "ranking" between different satellite products in particular when looking at the dispersion parameters like the standard deviation (STD), or the interquartile range (IQR). Keep in mind that low spatial and/or temporal resolution satellite SSS products tend to have lower dispersions than products at higher resolutions. For example, a level 2 (swath) product of a specific sensor will always have more dispersion than level 3 or 4 products where spatial and temporal averaging tend to reduce the instrumental noise and potential small scale variability. In general, products at $1^{\circ} \times 1^{\circ}$ spatial resolution have lower dispersion than products at $0.25^{\circ} \times 0.25^{\circ}$. Same result applies for monthly products compared to daily products.

5.2 Statistics derived for the different *in situ* databases

► Table 1 shows the mean, median, standard deviation (Std), root mean square (RMS), interquartile range (IQR), correlation coefficient (r^2) and robust standard deviation (Std^{*}) of the match-up differences Δ SSS (Satellite - *in situ*) between **ISAS** and all the available *in situ* datasets derived over the Southern Ocean Pi-MEP region and for the full satellite product period and considering all match-up pairs satellite/*in situ* SSS values to derive the statistics:
